Any monies left over will be returned to you at registration at the 2011 Washington State Cinderella Finals. Each contestant selling at least one full page ad will be eligible to become our next "Cover Girl or Cover Model". The contestant selling the most additional advertising will receive the Special Community Support Award. **You must sell one (1) full page ad to be eligible to receive the pageant fee credit on additional ads sold.** **NO sharing of ads for the Community Support & Cover Girl. If an ad appears with 2 contestants it will be counted as 2 one-half (1/2) page ads, one for each.**
